## CASE MANAGED SHELTER

Individuals staying at the Walworth Street shelters are working toward a better future one day at a time.



Houseguests gain self-sustainability by working collectively with case managers to identify employment and housing solutions.

## EMERGENCY SHELTER

**Code Blue** offers individuals basic needs of food and shelter during hazardous winter weather and opens the door for stabilization.



Nearly half of the people utilizing Code Blue transitioned to the Walworth Street shelters promoting further engagement with supportive services.

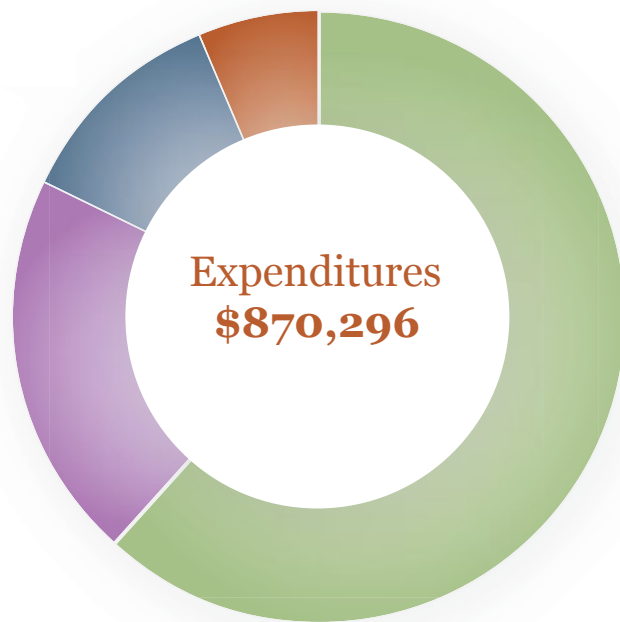
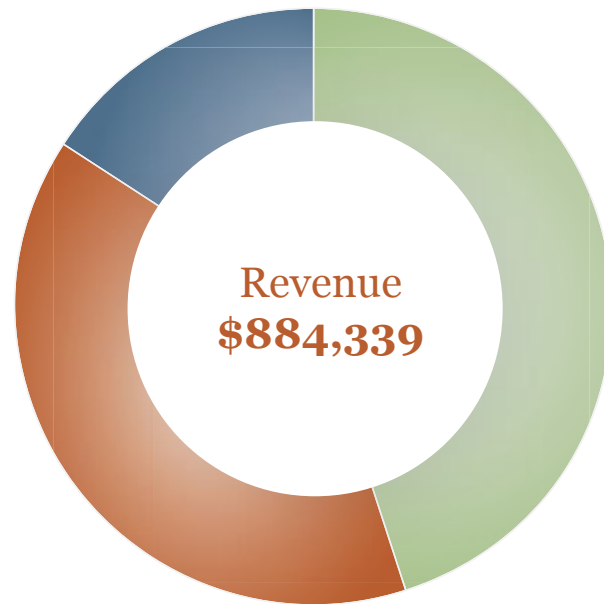
